What is the purpose of this update?

This document tells you how the Balanced Fund ('fund') has performed and what fees were charged. The document will help you compare the Fund with other funds. Consilium NZ Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

The Fund holds a diversified portfolio of growth assets and income assets. Holding a balanced mix of growth and income assets means this Fund is expected to have moderate to high long term returns and up and down movements in the fund's value.

What are the risks of investing?

Risk indicator for the Balanced Fund:



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

Example of how this applies to an investor

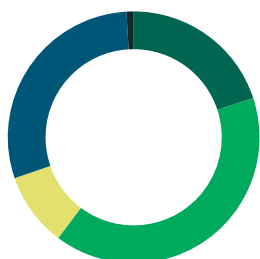
Small differences in fees and charges can have a big impact on your investment over the long term.

Sam had \$10,000 in the Fund on 15 April 2025 and did not make any further contributions. On 30 June 2025 Sam received a return, after fund charges were deducted, of \$1,325 (that is 13.25% of the initial \$10,000). This gives Sam a total return after tax of \$1,272 for the period.

What does the Fund invest in?

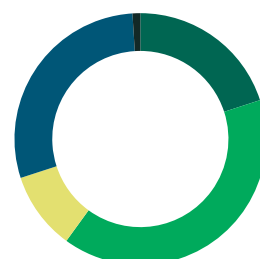
This shows the types of assets that the Fund invests in.

Currency Hedging

The Fund's international fixed interest exposure was 100% hedged. The Fund's international equities (excluding Australia) exposure was 40.04% hedged. The Fund aims to hedge 100% of the international fixed interest exposure, and 30% to 50% of the international equities (excluding Australia).

Notes

¹ The risk indicator is based on returns data for the past 5 years. As the Fund has not been in existence for 5 years, the risk indicators have been completed using market index returns, rather than actual returns. As a result of these market index returns being used, the risk indicator may provide a less reliable indicator of the potential future volatility of the Fund.
