

## Fund Update for the quarter ended 31 December 2022

This fund update was first made publicly available on 26 January 2023

### What is the purpose of this update?

This document tells you how the Evidential Sustainable Global Bond Fund ('Fund') has performed and what fees were charged. The document will help you compare the Fund with other funds. Consilium NZ Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

### Description of this fund

The Fund provides investors with exposure to a diversified portfolio of intermediate term global fixed interest and money market securities, whilst taking into account certain environmental and sustainability impact and social considerations. The Fund achieves this by purchasing units in a New Zealand dollar hedged class of the Dimensional Global Bond Sustainability Trust, an Australian unit trust registered as a managed investment scheme in Australia.

### What are the risks of investing?

Risk indicator for the Evidential Sustainable Global Bond Fund:

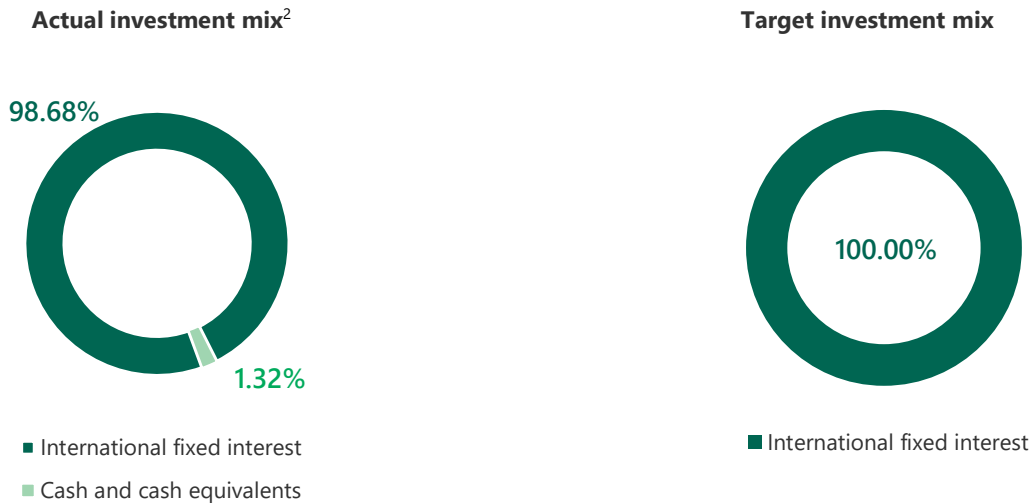
## Example of how this applies to an investor

Small differences in fees and charges can have a big impact on your investment over the long term.

Sam had \$10,000 in the Fund on 7 June 2022 (the date the Fund received its first contribution) and did not make any further contributions. At the end of the period to 31 December 2022, Sam received a return after fund charges were deducted of -\$154 (that is -1.54% of the initial \$10,000). This gives Sam a total return after tax of -\$94 for the period 7 June 2022 to 31 December 2022.
