

# Fund Update for the quarter ended 30 June 2023

This fund update was first made publicly available on 30 January 2024

## What is the purpose of this update?

This is a replacement fund update and replaces the one issued on the 28th of July 2023. This update corrects return data for the fund.

This document tells you how the Evidential Sustainable Global Bond Fund ('Fund') has performed and what fees were charged. The document will help you compare the Fund with other funds. Consilium NZ Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

## Description of this fund

The Fund provides investors with exposure to a diversified portfolio of intermediate term global fixed interest and money market securities, whilst taking into account certain environmental and sustainability impact and social considerations. The Fund achieves this by purchasing units in a New Zealand dollar hedged class of the Dimensional Global Bond Sustainability Trust, an Australian unit trust registered as a managed investment scheme in Australia.

## What are the risks of investing?

Risk indicator for the Evidential Sustainable Global Bond Fund:



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

## Example of how this applies to an investor

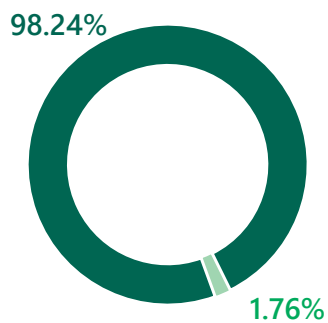
Small differences in fees and charges can have a big impact on your investment over the long term.

Sam had \$10,000 in the Fund on 1 July 2022 and did not make any further contributions. On 30 June 2023, Sam incurred a loss after fund charges were deducted of \$89 (that is -0.89% of the initial \$10,000). This gives Sam a total loss after tax of \$47 for the period.
