What is the purpose of this update?

This document tells you how the Growth Fund ('fund') has performed and what fees were charged. The document will help you compare the Fund with other funds. Consilium NZ Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

The Fund holds a diversified portfolio of primarily growth assets and some income assets. Holding a high proportion of growth assets means it is expected to have high long term returns, but there is also likely to be reasonably large up and down movements in the Fund's value

What are the risks of investing?

Risk indicator for the Growth Fund:



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

How has the fund performed?

Example of how this applies to an investor

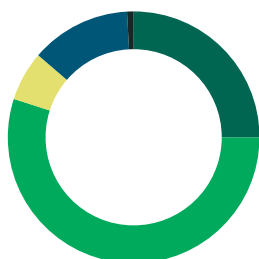
Small differences in fees and charges can have a big impact on your investment over the long term.

Sam had \$10,000 in the Fund on 1 July 2025 and did not make any further contributions. On 30 June 2026 Sam received a return, after fund charges were deducted, of \$1,685 (that is 16.85% of the initial \$10,000). This gives Sam a total return after tax of \$1,567 for the period.

What does the Fund invest in?

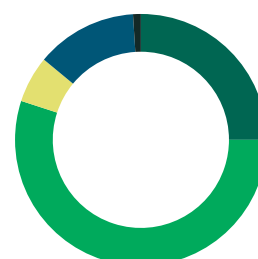
This shows the types of assets that the Fund invests in.

Currency Hedging

The Fund's international fixed interest exposure was 100% hedged. The Fund's international equities (excluding Australia) exposure was 40.32% hedged. The Fund aims to hedge 100% of the international fixed interest exposure, and 30% to 50% of the international equities (excluding Australia).

Notes

¹ The risk indicator is based on returns data for the past 5 years. The Funds have not been in existence for 5 years, so the risk indicators have been completed using actual returns where available and market index returns for the remainder of the 5 year period. As a result of these market index returns being used, the risk indicator may provide a less reliable indicator of the potential future volatility of the Fund.
