## What is the purpose of this update?


## Description of this fund

The Fund holds a diversified portfolio of primarily growth assets and some income assets. Holding a high proportion of growth assets means it is expected to have high long term returns, but there is also likely to be reasonably large up and down movements in the Fund's value

## What are the risks of investing?

Risk indicator for the Growth Fund:



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

## Example of how this applies to an investor


Small differences in fees and charges can have a big impact on your investment over the long term.

Sam had \$10,000 in the Fund on 15 April 2025 and did not make any further contributions. On 31 December 2025 Sam received a return, after fund charges were deducted, of \$1,974 (that is 19.74% of the initial \$10,000). This gives Sam a total return after tax of \$1,907 for the period.

## What does the Fund invest in?


This shows the types of assets that the Fund invests in.

## Currency Hedging

The Fund's international fixed interest exposure was 100% hedged. The Fund's international equities (excluding Australia) exposure was 39.67% hedged. The Fund aims to hedge 100% of the international fixed interest exposure, and 30% to 50% of the international equities (excluding Australia).

## Notes

<sup>1</sup> The risk indicator is based on returns data for the past 5 years. The Funds have not been in existence for 5 years, so the risk indicators have been completed using actual returns where available and market index returns for the remainder of the 5 year period.
