

# Fund Update for the quarter ended 30 June 2025

This fund update was first made publicly available on 28 July 2025

## What is the purpose of this update?

This document tells you how the Evidential Sustainable Global Bond Fund ('Fund') has performed and what fees were charged. The document will help you compare the Fund with other funds. Consilium NZ Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

## Description of this fund

The Fund provides investors with exposure to a diversified portfolio of intermediate term global fixed interest and money market securities, whilst taking into account certain environmental and sustainability impact and social considerations. The Fund achieves this by purchasing units in a New Zealand dollar hedged class of the Dimensional Global Bond Sustainability Trust, an Australian unit trust registered as a managed investment scheme in Australia.

## What are the risks of investing?

Risk indicator for the Evidential Sustainable Global Bond Fund:



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

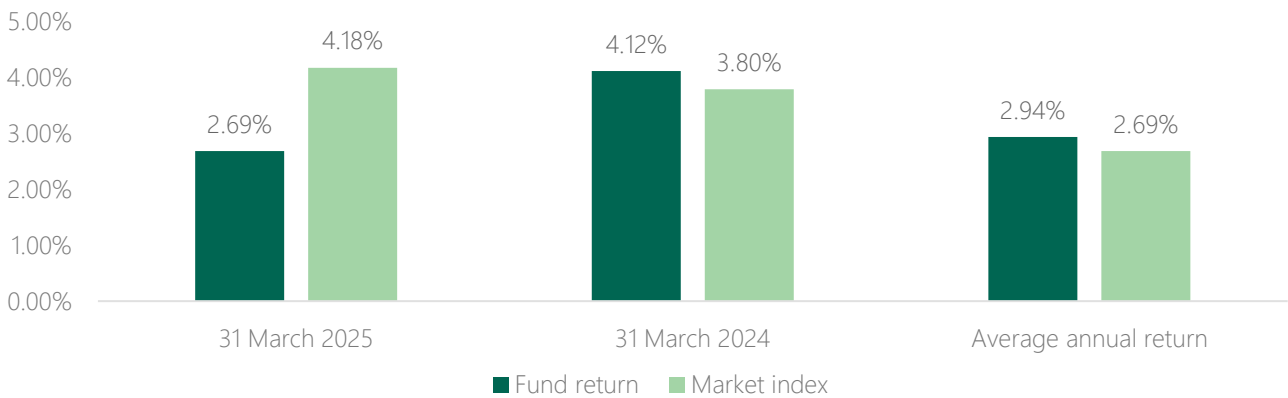

## What fees are investors charged

Investors in the Evidential Sustainable Global Bond Fund are charged fund charges. In the year to 31 March 2025 these were:

From 1 August 2024, the Manager's basic fee reduced from 0.35% to 0.32%.

## Example of how this applies to an investor

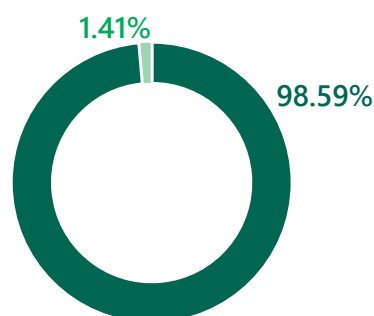
Small differences in fees and charges can have a big impact on your investment over the long term.

Sam had \$10,000 in the Fund on 1 July 2024 and did not make any further contributions. On 30 June 2025 Sam received a return, after fund charges were deducted, of \$543 (that is 5.43% of the initial \$10,000). This gives Sam a total return after tax of \$391 for the period.
